## Terms and Conditions of the international educational project Global Atomic Quiz

### 1. General Provisions

These Terms and Conditions determine the procedure and terms of the international educational project "Global Atomic Quiz" (hereinafter referred to as the "Project"), including the rules of the participation in the Project and the winners selection process.

The Project's goal is to increase public knowledge of nuclear physics; educate a wide international public about the latest world achievements in nuclear industry and the various benefits of the peaceful use of nuclear technologies.

The target audience of the Project (hereinafter referred to as the "Participants"): wide international audience, including:

- middle and high school students, as well as anyone between 11 and 16 years old (hereinafter referred to as the "Youth");
- members of the general public aged 17 years and older (hereinafter referred to as the "Adults").

By participating in the Project, the Participants fully agree with these Terms and Conditions (hereinafter referred to as the "Terms and Conditions").

The Project is governed by the Terms and Conditions. The Project is a non-profit outreach initiative; it is neither a promotion event nor a lottery.

#### General Information

- 1.1. Title: international educational project "Global Atomic Quiz".
- 1.2. Participants from any country in the world are eligible to participate in the Project.
- 1.3. The Project Organizer: the Autonomous Non-Profit Organization for the Development of Information Centers for Atomic Energy "Energy of the Future" (ANO Energy of the Future), located at the address: 117105, Russian Federation, Moscow, Varshavskoe shosse (hereinafter referred to as the "Organizer").
- 1.4. Project duration:
- 1.4.1. The total period for holding the Project is from November 10, 2021 to the date when the prizes are awarded to the winners, but not later than December 31, 2022. The duration of the Project includes the period when the Participants take the actions required to participate in the Project; the time required for the Organizer to select the Project winners; and the time required for the Organizer to award the prizes to the winners based on the Project results.
- 1.4.2. The period for holding the main part of the Project: Participants shall take the quiz, which tests the knowledge of nuclear physics and nuclear technologies (hereinafter referred to as "the Quiz") at any time in the period from 00 hours 00 minutes 00 seconds on November 10, 2021 till 23 hours 59 minutes 29 seconds on November 10, 2021 (local time zone of the Participant).
- 1.4.3. The Organizer shall make a preliminary list of the Participants, who have the maximum number of correct answers, within seven (7) calendar days after the Quiz ends.
- 1.4.4. Winners of the Project shall be announced not later than November 26, 2021.
- 1.4.5. Winners of the Project will be awarded the Prizes, in accordance with the Terms and Conditions, in the period from April 1, 2022 to December 31, 2022.
- 1.4.6. The exact dates for awarding the Prizes will be determined by the Organizer later, and the Project winners will be notified at least thirty (30) days in advance.
- 1.4.7. The Organizer reserves the right to change the timeframes indicated in clauses 1.4.3. 1.4.5. of the Terms and Conditions.

- 1.4.8. If the awarding of the Prizes to the winners is impossible due to reasons beyond the Organizer's control (including, but not limited to, force majeure, natural disasters, decisions of local and/or federal authorities to impose quarantine measures, inability of a winner to attend the educational events), the Project Participants will be informed additionally.
- 1.4.9. The Organizer reserves the right to cancel the educational events or change the dates.
- 1.5. Ways of informing the Participants:

The Terms and Conditions, Project timeframes and results will be published on the Project's Website: quiz.atomforyou.com, including all language versions (hereinafter referred to as the "Website").

1.6. Initial contact with the Participants and/or with their parents/legal representatives, which includes verification of data and identity documents, shall only take place from the Project's email address: <a href="mailto:info@atomforyou.com">info@atomforyou.com</a>.

## 2. Eligibility

- 2.1. The Participants of the competition within the Project may be individuals who are at least 11 years old on the Project date, in accordance with target audience categories defined in these Terms and Conditions. All other participants can take part in the Project, but will not be considered for the competition.
- 2.2. The Participants under the age of 18, who, due to the current legislation, cannot act independently under these Terms and Conditions, shall do so through their parents (or legal representatives) and/or with their assistance.
- 2.2.1. It is the responsibility of the minor Participants to inform their parents (legal representatives) of these Terms and Conditions, to obtain the necessary consents from their parents (legal representatives), including the consent to participate in the Project.
- 2.3. The following individuals shall be excluded from the competition within the Project:
  - employees of the Organizer; individuals representing the Organizer; their family members;
  - third parties' employees and representatives, who have a contractual relationship with the Organizer and are associated with the Project, as well as their family members.
- 2.4. The Project Participants have the right to receive information about the Project, in accordance with these Terms and Conditions;
- 2.5. The Project Participants shall have the following responsibilities:
  - comply with the Terms and Conditions while participating in the Project;
  - provide the Organizer with correct and truthful information in accordance with the Terms and Conditions;
  - other responsibilities determined by these Terms and Conditions.

# 3. General Description and Project Participation Procedure. Project Winners Selection.

- 3.1. The winners of the Project are those Participants, who, in accordance with the Terms and Conditions, will be eligible to receive a Prize from the Organizer.
- 3.1.1. The Organizer will arrange participation of the winners in the educational trips, in accordance with clause 4 of these Terms and Conditions. Participation in the educational trips is not intended to generate income for the Participants, being an educational initiative intended to educate Participants about the Russian nuclear industry and technologies.
- 3.2. In order to participate in the Project, an applicant, who wishes to become a Project Participant and meets the requirements of clauses 2.1. and 2.2. of the Terms and Conditions shall register on the Website.

- 3.2.1. Registration on the Website requires the applicants to provide the following information:
  - First and last names;
  - Date of birth:
  - Contact information (valid mobile phone number and e-mail address);
  - The Participants who are young professionals in nuclear industry between 18 and 34 years old should additionally indicate their job title and place of work;
  - Consent to participate in the Project and to the processing of personal data;
  - Consent from a parent/legal representative to participate in the Project and consent from a parent/legal representative to the processing of personal data for minor Participants.
- 3.2.2. Applicants, who provided incorrect and/or incomplete information upon registration, will not become Project Participants or will subsequently be excluded at any stage of the Project, when the Organizer becomes aware of the violation. In order to verify information provided by the Participants in the registration form, the Organizer shall be entitled to request (by e-mail) a copy of the Participant's passport or other identity documents. If the requested documents are not submitted within more than two (2) days from the request date, the Organizer may exclude such applicant from the participants list.
- 3.2.3. The Organizer reserves the right to deny participation in the Project to those applicants whose registration forms have not been properly completed (if incomplete or incorrect information has been entered). Once registered, the Participant cannot change the mobile phone number and e-mail address entered when registering on the Website.
- 3.2.4. Only one entry to the competition will be accepted per Participant.
- 3.3. Participants who are eligible for the Prize (participation in educational trips) will be determined by the following requirements:
- 3.3.1. The first requirement: Participants shall complete the quiz dedicated to nuclear physics and the latest technologies in nuclear industry.
  - 3.3.1.1. The Quiz takes place online at quiz.atomforyou.com.
  - 3.3.1.2. The Quiz consists of 15 questions of varying difficulty about nuclear technologies, to which the Participant shall answer by choosing the correct answer from those offered by the computer.
  - 3.3.1.3. The questions are divided into two categories according to the Participant's age:
  - Youth category for participants between 11-16 years old.
  - Adults category for participants aged 17 years and over.
    - 3.3.1.4. A Participant can answer the quiz questions only once.
    - 3.3.1.5. There is no time limit for answering the questions.
    - 3.3.1.6. The Participant may proceed to the next question by answering the previous one.
    - 3.3.1.7. When the Quiz ends, an automatic Participants' ranking is generated based on the number of correct answers; the more correct answers a Participant has, the higher is his/her position in the Participants' ranking.
    - 3.3.1.8. If two or more Participants score the same number of correct answers, they are ranked the same way when the automatic ranking is generated.
- 3.3.2. The second requirement: selection of the Project winners.
- 3.3.2.1. The Organizer shall, not later than two (2) days after the deadline specified in clause 1.4.2. of the Terms and Conditions, create a preliminary list of the Participants who have scored the maximum number of correct answers.
- 3.3.2.2. The Organizer will contact the Participants from the preliminary list via email to verify their eligibility and personal information provided in the registration form. The Organizer

shall request a scan copy of the Participant's passport or other identity document, copies of the Participant's consent forms or consent forms of the Participant's parent/legal representative to participate in the Project, to process personal data and participate in the educational trip.

- 3.3.2.3. If, within two (2) calendar days of the request date, the Organizer has not received the documents and/or the Organizer has any sufficient reason to believe that the Participant has provided deceitful information (including, but not limited to, if the phone number or email does not match those provided at registration; the Participant has misrepresented his/her age; registered under a false name) such applicant will be excluded from the preliminary list and will lose the right to receive the Prize.
- 3.3.2.4. Entry in the preliminary list does not automatically make the Participant a winner.
- 3.3.2.5. The winners in each Prize category will be selected from the preliminary list by a random selection carried out by a third-party computer application by 26 November 2021.
- 3.3.2.6. After the winners have been selected, the Organizer publishes the results on the Website by indicating the names of all winners. The winners will also be notified by email. If the winner does not reply to the Organizer within fourteen (14) days of the notification e-mail, the winner's Prize will be cancelled and the Organizer will be entitled to select another winner in accordance with the procedure described above.

## 4. Prizes for the Project Winners

- 4.1. All registered Participants will receive digital certificates of participation.
- 4.2. Top Prizes for the Project winners:
- 4.2.1. Youth category (Participants from 11 to 16 years old): winners are given the opportunity for a paid trip to one of the shifts of the international camp "Smart Holidays with Rosatom School" in Russia.
- 4.2.1.1. No more than three (3) Participants may win the Prize in this category.
- 4.2.1.2. The winners and one accompanying person for each of them are provided with accommodation, meals, health insurance, air travel from their home country to the country of the camp, as well as transfers to and from the campsite.
- 4.2.2. Adults category (Participants aged 17 and over): the winners have the opportunity to go on a paid educational trip to one and/or more of Rosatom's nuclear facilities.
- 4.2.2.1. No more than ten (10) Participants may win the Prize in this category. The Participants shall be at least 18 years old at the time of the educational trip.
- 4.2.2.2. The Participants shall be provided with accommodation, meals, health insurance, air travel from their home country to the country of the event and back, transfers to and from the location of the educational event.
- 4.2.3. Special category "Young Professionals in Nuclear Industry": the winners shall have the opportunity to attend the International Youth Nuclear Congress (IYNC-2022), which will be held in Sochi, Russia, from May 22 to 27, 2022.
- 4.2.3.1. No more than ten (10) Participants may win the Prize in this category. The Participants shall be between 18 and 35 years old as of May 2022. Only young professionals in nuclear industry are eligible to participate.
- 4.2.3.2. The Participants shall be provided with accommodation, meals, health insurance, air travel from their home country to the country of the event and back, as well as transfers to and from the venue of the congress.
- 4.3. The Organizer does not accept any responsibility for visa costs, and is not responsible for the refusal of the Embassy/Consulate of the Russian Federation to issue visas for the winners. In case of refusal, the Participant has no right to demand any compensation related to participation in the Project.

- 4.4. If a citizen of the Russian Federation receives the Prize, in accordance with clause 5 of Article 226 of the Tax Code of the Russian Federation, the Organizer shall notify the winner (winner, Prize recipient, taxpayer) and the tax authority at the place of its registration about the inability to withhold personal income tax (PIT), within one month from the end of the tax period in which the corresponding obligations have arisen. Given the provisions of <u>Sub-Clause 4 of Clause 1 of Article 228 of the Tax Code</u> of the Russian Federation, the winner (winner, recipient of the Prize, the taxpayer) shall calculate and pay personal income tax (PIT) on income in the amount of the Prize of more than 4,000 rubles, in the manner prescribed by <u>Article 228 of the Tax Code</u> of the Russian Federation.
- 4.5. The Organizer shall not be responsible for possible taxes and fees required by the legislation of any foreign country in connection with the receipt of the Prize. All responsibilities for the payment of taxes and fees are borne by the recipient of the Prize.

#### 5. Final Provisions

- 5.1. All disputes and disagreements, which arise in connection with the Project organization and performance, shall be settled by negotiations. Disputes not resolved by negotiations shall be settled in court at the Organizer's location in accordance with the substantive and procedural law of the Russian Federation.
- 5.2. The costs of obtaining all the documents required by these Terms and Conditions and of carrying out all the activities aimed at participating in the Project shall be borne by the Participants, parents and/or legal representatives themselves.
- 5.3. All documents shall be provided in either a readable handwritten form or a clean scan copies/photocopies; otherwise, the Organizer has the right to deem them inappropriate.
- 5.4. An event may occur, in which organizing and holding the educational trips becomes impossible for reasons beyond the Organizer's control (including, but not limited to, force majeure, natural disasters, decisions of local and/or federal authorities to impose quarantine measures, regions lockdown). In such a case, the Organizer has the right to cancel the events or change their dates at its own discretion. The Participant shall not be entitled to claim any compensation.
- 5.5. The Organizer shall be entitled to engage third parties to carry out any activities within the Project's framework.
