

Rules for conducting international educational the «Global Atomic Quiz» project

1. General provisions

These rules determine the procedure and timing of the international educational project “Global Atomic Quiz” (hereinafter referred to as the Project), including the rules for participation in the Project and the procedure for summing up the Project results.

The goal of the Project is to popularize knowledge about the basics of nuclear physics, educate an international audience about the latest world achievements in the field of nuclear technologies and the advantages of their use for peaceful purposes.

The target audience of the Project (hereinafter referred to as the Participants) is a wide international audience, namely persons from any country in the world who meet the requirements and comply with the conditions provided for by these rules.

By taking part in the Project, Participants fully agree to these rules (hereinafter referred to as the Rules).

The project is regulated by these Rules, is a non-profit educational event, is not an advertising incentive event and is not a lottery.

General information

1.1. Name: International educational project “Global Atomic Quiz”.

1.2. The project is held on the website www.quiz.atomforyou.com without limiting the territory where the participants are located and their affiliation with any state. The laws of the Russian Federation apply to relations arising in connection with the implementation of the Project.

1.3. The organizer of the Project is: Autonomous non-profit organization for the development of information centers on atomic energy “Future Energy” (ANO Future Energy), INN 7726385219, KPP 772601001, legal address: 117105, Moscow, Varshavskoe sh., 3 (hereinafter referred to as the Organizer).

1.4. Project duration:

1.4.1. The general duration of the Project: from November 10, 2025 until the Prizes are issued to the winners, but no later than December 31, 2025. The total duration of the Project includes the period during which the Project Participants perform the actions necessary to participate in the Project; the time required by the Organizer to determine the winners of the Project; as well as the time required by the Organizer to transfer prizes to the Winners based on the results of the Project.

1.4.2. The period for conducting the main part of the Project is completing tasks of a popular science quiz on knowledge of the fundamentals of nuclear physics and world achievements of the nuclear industry (hereinafter referred to as the Quiz) - from 00 hours 00 minutes 00 seconds on November 10, 2025 to 23 hours 59 minutes 59 seconds on November 10, 2025 (according to the time of the Participant’s place of stay).

1.4.3. The period for summing up the results and announcing the winners of the Project is until November 22, 2025 inclusive.

1.4.4. The period for awarding Prizes to winners based on the results of participation in the Project in accordance with the Rules is from November 22, 2025 to December 12, 2025 inclusive.

1.4.5. The exact dates for issuing Prizes will be determined later, about which the Project Participants will be notified separately by the Organizer.

1.4.6. The deadlines specified in paragraphs 1.4.3. – 1.4.5., may be changed by the Project Organizer with notification of Participants on the Project website www.quiz.atomforyou.com.

1.4.7. If it is impossible to award prizes to the winners for reasons beyond the control of the Organizer (including, but not limited to, force majeure, natural disasters, restrictions and prohibitions

when sending international mail), Project Participants will be additionally informed about this. In this case, the organizer, at its discretion, has the right to cancel the transfer of competition prizes or change the timing of their issuance.

1.5. Ways to inform Project Participants:

Participants of the Project will be informed about the Rules, timing and results of the Project on the Internet: on the website quiz.atomforyou.com, including all its language versions (hereinafter referred to as the Site).

1.6. Primary communication with Participants and/or their parents/legal representatives, including verification of personal data, is carried out only from the Project's email address: info@atomforyou.com

2. Participants and Conditions of participation in Project

2.1. Participants in the competitive part of the Project can be individuals from any country in the world who have filled out the registration form and consented to the processing of personal data on the Project website. Individuals can take part in the Project without registration, but they will not be considered as part of the competition.

2.2. Minor Project participants who, due to the requirements of the national legislation of the country of their residence or citizenship (hereinafter referred to as national legislation), cannot independently perform the actions provided for by these conditions, but perform them through their parents (or legal representatives) and/or with their help.

2.2.1. Parents (legal representatives) of minor participants in the Project are independently responsible for familiarizing themselves with these Rules and providing the necessary consents in accordance with national legislation, including for the minor's participation in the Project and for the processing of his personal data.

2.2.2. The Organizer assumes that all actions of minor Participants within the Project were carried out by them with the consent of or through their parents or legal representatives and do not contradict national legislation.

2.2.3. The Organizer has the right to remove a minor Participant from participation in the Project if it is discovered that the necessary consent of his parents or legal representatives is lacking.

2.3. The following are not allowed to participate in the competitive part of the Project:

- employees of the Organizer, as well as persons representing the interests of the Organizer, as well as members of their families;
- employees and representatives of third parties who have contractual relations with the Organizer, as well as those associated with the organization and/or conduct of the Project, as well as members of their families;
- employees and representatives of enterprises of the State Corporation Rosatom.

2.4. Project participants have, in particular, the right to receive information about the Project in accordance with these Rules.

2.5. Project participants bear the following responsibilities:

- comply with the Project Rules during its implementation;
- provide the Organizer with reliable information about yourself in accordance with the Project Rules;
- other duties provided for by these Rules.

3. Procedure for participation in the Project competition. Determination of the Project Winners.

3.1. Based on the results of the competition part of the Project, Winners will be determined who, in accordance with the Project Rules, will receive prizes from the Organizer (hereinafter referred to as the Prizes).

3.2. To participate in the competitive part of the Project, the Participant must fill out a registration form on the Site.

3.2.1. Registration on the Site requires the applicant to provide the following information about himself by filling out the appropriate registration form:

- Last name, first name;
- Date of birth;
- Email address;
- Country of Residence;
- A mark of consent to participate in the Project, process personal data and receive newsletters;

3.2.2. The Organizer has the right to refuse participation in the competitive part of the Project to those Participants whose registration forms were not filled out properly (incomplete or incorrect information was entered). After registration, the Participant is not able to change the email address entered when registering on the Site.

3.3. The Winners are determined in the following order:

3.3.1. Registered Participants must complete the tasks of the popular science Quiz on knowledge of the basics of nuclear physics and world achievements in the nuclear industry.

3.3.1.1. The quiz takes place on the Internet at quiz.atomforyou.com, including all language versions.

3.3.1.2. The quiz consists of two levels: simple and difficult. Each level consists of 9 (nine) questions on topics related to nuclear physics and world achievements in the nuclear industry, which the Participant must answer by selecting the correct answer from those proposed by the system.

3.3.1.3. The participant, after passing the simple level, can complete participation in the Quiz. Completing a simple level gives the Participant the right to receive an electronic certificate/diploma and compete for simple level prizes. If the Participant does not move to the next difficulty level, then the Participant will not be able to take part in the prize draw of a difficult level.

3.3.1.4. After passing a difficult level, the Participant has the right to receive a certificate/diploma and compete for prizes at a difficult level.

3.3.1.5. The Quiz Participant cannot receive prizes for completing easy and difficult levels at the same time.

3.3.1.6. The Participant can answer the Quiz questions only once. Participants who complete the Quiz more than once will not be considered for the competition.

3.3.1.7. The participant can move on to the next question by answering the previous one.

3.3.1.8. The response time for each Quiz task will be tracked using a timer. The speed of completion of all tasks will be taken into account in the Participant's final score when compiling the ranking of Winners.

3.3.1.9. Based on the number of correct answers and the speed of completing the Quiz, an automatic ranking of Winners is formed. The more points a Participant receives, the higher his position in the ranking.

3.3.2. The Participant's final score is formed from the following components:

3.3.2.1. The number of correct answers in each of the sections has a different weight: the section "True or false?" – 1 point for each correct answer; rubric "Choose one of..." – 2 points for each correct answer; rubric "In order" - 0 points if there are no matches, 1 point - for one match out

of four, 2 points - for two matches out of four, 3 points - for three matches out of four, 4 points if all options are located correctly.

3.3.2.2. Additionally, the speed at which Quiz tasks are completed is taken into account when calculating the Participant's final score. A time factor is applied to each question, taking into account the speed of response to each question.

3.3.2.3. The higher the final total of points, the higher the place in the Participants' ranking.

3.3.2.4. In the event of equal scores for several participants, the Participant who completed the quiz faster is considered to have taken a higher place.

3.3.3. Confirmation of the Project Winners:

3.3.3.1. In order to have a balanced geographical representation of the Winners, by November 22, 2025, the Organizer will determine 100 Quiz Winners based on the ranking of finalists in accordance with the country/regional quota established by the Organizer. The quota for a country/region is determined by the Organizer upon completion of the Project in proportion to the total composition of the countries or regions of the Participants.

3.3.3.2. The Organizer, no later than 12 (twelve) calendar days after the end of the period specified in clause 1.4.2. of the Rules, publishes a list of Winners on the Project website, by indicating the Last Name and First Name of all Winners and their identification number. Winners will also be notified by email.

3.3.3.3. The Organizer contacts the Winners by email to verify compliance with the requirements for Participants and compliance of their data specified during registration. At the same time, the Organizer sends the Winners a request to send by e-mail to the Project additional data necessary to organize the receipt of Prizes.

3.3.3.4. If the winner does not respond to the Organizer within 4 (four) calendar days from the receipt of the notification and/or the Organizer has reasonable doubts about the correspondence of the data about the Participant specified during registration with the real data, including, but not limited to, if the email does not correspond to those specified during registration, or the Participant distorted personal data, registered under a fictitious and/or false name, the decision on the winner will be canceled and the Promoter will have the right to select an alternate winner in accordance with the procedure described above.

4. Prizes for Project Participants

4.1. Based on the results of the Project, all Participants registered to participate in the Project will receive personalized electronic certificates/diplomas from the Project Organizer.

4.2. No more than 100 Participants can become winners of the competitive part of the Project, based on the ranking of finalists in accordance with the country/regional quota established by the Organizer.

4.3. The winners of the competitive part of the Project will receive access to advanced neural networks (chat bots and tools for generating content), educational platforms with courses from leading world experts, as well as lifestyle services for developing thinking and working with mental health (hereinafter referred to as the Prize).

4.3.1. Within 10 (ten) days after the end of the period specified in clause 1.4.2., the Organizer sends a letter to the Participant's email address, which indicates the procedure for receiving the Prize and the list of necessary information and documents for receiving it.

4.3.2. Prizes are sent by sending them to the email address provided by the Winner.

4.3.3. Prizes are provided to the winners of the competitive part of the Quiz. Each winner has the right to choose one Prize from the proposed list. The Prize is selected in the order in which applications are received from the winners.

4.3.4. The number of prizes of each type is strictly limited. In the event that the selected prize has already been distributed, the winner may select an alternative from the remaining prizes. The organizers reserve the right to replace the prize with an alternative if it is impossible to provide it.

4.4. 3 (three) winners of the competitive part of the Project, based on the ranking of finalists in accordance with the country/regional quota established by the Organizer, receive a prize in the form of a trip to Russia in 2026.

4.4.1. The Winners will be informed separately about the conditions, date, time and composition of the trip via the email address specified when registering on the Site.

5. Final provisions

5.1. All disputes and disagreements that arise in connection with the organization and implementation of the Project must be resolved through negotiations. Controversial issues that are not resolved through negotiations are subject to resolution in court at the location of the Organizer in accordance with the substantive and procedural law of the Russian Federation.

5.2. The costs of obtaining all documents provided for by these Rules, for performing all actions aimed at participating in the Project, are borne by the Participants, parents and/or legal representatives themselves.

5.3. All documents in simple handwritten form must be written legibly and clearly. Scanned copies and photocopies must be completely readable, otherwise the Organizer has the right to consider them improper.

5.4. If it is impossible to transfer the Prizes within the planned time frame for reasons beyond the Organizer's control, the Organizer, at its sole discretion, has the right to cancel or change the delivery time. In this case, the Participant has no right to demand any compensation related to participation in the Project.

5.5. To carry out the Project and perform any actions within the framework of the project, the Organizer has the right to involve third parties.
